- 5. Park Management

 - b. Livy reported someone fell on Fieldstone Loop East trail and landed on a sharp rock.
 - c. There has been another complaint regarding 'off leash dogs'. There was a discussion but no action taken.
 - d. Kristian asked if the board has ever considered building a foot bridge from the middle school property to the off leash area. He suggested that this addition might decrease the number of off leash dogs. Livy did not believe that idea has ever been considered.
 - e. Jim reported on the grant which was submitted in December. We have requested \$32,005.98 in Vermont RTP funding to renovate the Fieldstone West Loop Trail. If the grant is approved our 20% matching portion will be \$8,001.50. In addition, we will need to spend an additional \$13,335 to finish the project.
 - f. Livy will be leaving the area for the month of February. She needs someone to help with dog waste removal. Suzanne will cover the 1st week of Feb. Jim will do the second week. Coverage for the 3rd week and 4th week will be decided at the February meeting.
 - g. Livy has lined up bands for 4 of the 5 summer concerts.
 - h. Summer soccer camp has already reserved field use time for June/July.
